3. (a) A degree with specialization in the relevant subject without Honors or any other general degree with at least Second-Class Honors,

AND

- (b) A Postgraduate Degree with duration of at least 02 academic years in the relevant subject with a research component by way of thesis/ dissertation;

OR

4. (a) A Degree or equivalent professional qualification offered or recognized by a professional institution established by an Act of Parliament of Sri Lanka in the relevant subject,

AND

- (b) One year Master Degree in the relevant subject or equivalent further professional qualification offered or recognized by a professional institution established by an Act of Parliament of Sri Lanka,

AND

(c) (i) Five (5) years professional experience after graduation or after securing professional qualification given in 4 (a) (for external applicants)

OR

(ii) Five (5) year - teaching/ library experience after graduation or obtaining equivalent professional Qualification given in 4 (a) (for Internal applicants) in recognized Higher Educational Institution.

OR

5. (a) A degree or equivalent professional qualification offered or recognized by a professional institution established by Act of parliament of Sri Lanka in the relevant subject,

AND

(b) Eight (8) years professional and/ or teaching experience after graduation or after securing professional qualification given in 5 (a).

2. DEMONSTRATOR

A Degree in the relevant field.

3. INSTRUCTOR

A Degree in a field relevant to English Language.

OR

National Vocational Qualifications Level 06 and 05 years working experience in the relevant field in a government department, Corporation or recognized mercantile establishment.
