### 02. Date of Qualification:

Applicant is accepted as qualified to apply for the above service / post only if he or she had fulfilled the required qualifications in every aspect as at the closing date of applications.

03. Nature of Appointment:

This post is permanent. Employee should contribute 10% of the salary to the Employees Provident Fund (EPF) while the Authority will contribute 15% to the Employees Provident Fund and 3% to the Employees Trust Fund (ETF).
